- Match Starting:** 1:00 PM. on Every Match Day. (OR any changes will be notified by email)
- Match System:**

- 1) **Eligibility:** ALL Table Tennis existing members and new newcomers!
- 2) **Entry Limited:** 12 to 24 people per Match date. A Backup players Pool will be opened if there is any absent spot available.
- 3) **Match Format:** All matches are best 3 of 5

Phase 1: Group Round Robin. Notice will be sent before the game starts)

- All Players will be divided into groups by rating (based on the April Canadian Rating).
- Top-ranking players will be the seed in each group. The group size will have 3 to 6 players based on the entries.
- Each competition day will have a draw based on the rating points.

Phase 2: Knock-out stage. There will be A, B, and C three groups to play each position standing.

For example, the 1st and 2nd winners in the round-robin groups will advance to knockout group A, the 3rd and 4th winners in the round-robin groups will advance to knockout group B, the 5th and 6th winners in the round-robin group will advance to knockout group C, then every position will be played. How many winners advance to 3 knockout groups will be decided according to the master entries of each match date.

The results will be reported to TTCAN for rating publication.

4) Results

Weekly Results --- Match standing positions will be announced by email or online after the counting.

Serie Results --- Weekly results will be added up as a final result for each series.

Warm-Up: Warm-up begins at 12:30 pm.

Prize: Trophies, medals, or other prizes might be presented depending on the sponsors.

Award will be given to the 1st and 2nd for the whole series' standings in knockout group A, and two 1st in the knockout group B and C.

Rules: The Current ITTF Laws of Table Tennis will be in effect.

All Rackets must be on one side in black and any color on the other side with ITTF-approved coverings. If any illegal racket, the match result will not be submitted to TTCAN.

All illegal servings will be warned.

Tie breaks in round robins will be decided by the score of matches, games, and points for only those players involved in the tie.

Only shorts and T-shirts are allowed to be worn during the matches. **The color of the playing shirt must not be white.**

Non-marking shoes must be worn in the gym and street shoes are not allowed.

Players need to bring their own rackets and practice balls.

Umpiring: Players will be required to umpire their matches.
