NOTE

- There are 3 team divisions. Each team consists of 3 players (no sex restriction). Div. 1 -- U5000; Div. 2 -- U3600; Div. 3 -- U1800. The total 3 players combined rating has to be U5000, U3600, and U1800 to match the team registration
- Each player must register the same recorded name as his/her in the TTCAN rating system. Seeding will be based TTCAN July's Rating.
- A USA player must report his/her US rating points.
- Each player can register 2 events.
- Cancellation must be submitted by email to bcttatournament@gmail.com before Aug 7th 3pm, and A \$20 administration fee will be applied. No refund will be allowed if the cancellation is after Aug 7.
- Cash awards are subject to change depending on the number of entries.
- Div 2 & 3 Consolation rounds will be played if there is enough schedule.
- The tournament committee reserves the right to combine or cancel the event if there are fewer than 4 entries.

Eligibility

Open to all genders. 3 players per team in 3 divisions: U5000, U3600 and U1800. 3 players' combined rating not to exceed the registration division.

Format

Each division will have a preliminary round-robin followed by knockout. 2 teams will advance. For the U3600 Team and U1800 Team events, the 3rd and 4th team might play consolation if there is enough schedule.
Olympic Team format: Doubles BC v YZ, A v X, C v Z, A v Y, B v X. All matches are best 3 of 5, each game is best 2 of 3 to 11 points.

Rules

- Current ITTF Laws of Table Tennis will be in effect.
- All rackets must be one side black and one side of any other color with ITTF-approved coverings.
- Tie breaks in round robins will be decided by the score of matches, games, and points, only of those players involved in the tie.
- Only shorts and T-shirts are allowed to be worn during matches unless consent is given by the tournament referees. **The color of the playing shirt must not be white.**
- **Non-marking shoes must be worn in the gym and street shoes are not allowed.**
- Players need to bring their own rackets and practice balls.

Umpiring

- All players must be volunteering to umpire all matches.
